Topic:

A fundamental challenge to the state-centric international human rights regime is the growing agency of actors that do not neatly fall into the category of states, but have a significant influence on human rights. These include non-state actors, such as business enterprises or civil society organizations, as well as intergovernmental, regional and international organizations. In the context of global governance, privatization and the proliferation of international institutions, these actors gain the power and legitimacy to participate in the development and interpretation of norms and rules, in the provision of public goods and in the framing of public interests. These developments challenge the international human rights regime and its capability to deal with actors, powers and practices that fall outside of its traditional state-centric scope. This conference draws on these developments to discuss research which challenges the dichotomy of public and private – without necessarily leaving these concepts behind or simply blurring the boundaries. It aims to explore perspectives which take the plurality of non-state and intergovernmental actors into account, in order to contribute to new models of human rights responsibility which go beyond the ‘private’ responsibility to respect and the ‘public’ duty to respect, protect and fulfil human rights.
